## **BTEC Child Development - Early Years Setting Visit**

I am writing to invite your child to attend a visit to a local Early Years Setting as part of their BTEC Child Development course. The trip is on **Friday 11 October** and **Friday 25 October** with half the class going on Friday 11 October and the other half going the following week on Friday 25 October. We will be going to Little Shipmates Day Nursery for an afternoon visit during periods 4 and 5, which is when the students have a double session of BTEC Child Development so fortunately they will not be missing any other lessons.

During their current classwork the students are learning about how to organise and set up activities for children of various ages to help them learn and develop. They are also learning about the various additional needs that some young children have and how to adapt and provide resources to support them. Enabling the Noadswood students to observe all of this excellent practice will hopefully bring what they are learning about in the classroom 'to life' and therefore gain a better understanding of how children learn and how adults can support them.

On the afternoon of their visit the students will need to register with me promptly at the start of period 4. We will travel to Little Shipmates by minibus and then remain there for the rest of the afternoon. At approximately 2.45pm we will travel back to Noadswood and arrive as school finishes at 2.50pm.

The students can wear their school uniform for this trip, or if they prefer, they can change into something more comfortable/suitable to be working with young children and babies. There is no cost for this visit. If you are happy for your child to participate then please click the 'I give consent' button on Arbor under the Trip section. If you have any further questions, please contact me via email.

We take seriously our responsibility for the safety and welfare of our students at all times. This raises particular issues when students are involved in an activity off-site. Before taking students away from the school site, we carry out a thorough risk assessment and take all necessary measures to minimize risks including arranging appropriate levels of supervision by responsible adults. We expect that students involved in the activity will cooperate fully with the arrangements made and follow closely the instructions of the responsible adults throughout the activity. We therefore reserve the right to refuse a place on the trip to any students where there has been a behaviour concern previously.
