## PROPOSAL FOR VARIATION TO THE ADMISSIONS ARRANGEMENTS FOR SEPTEMBER 2026

In accordance with the DfE's 2021 statutory 'School Admissions Code', a school must consult on admission arrangements when changes are proposed, and at least once every seven years.

The Trustees of Noadswood School have decided to consult on the school's Admissions Policy for the academic year 2026-27. The consultation period will run for at least six weeks, from 14 January 2025 until 26 February 2025. During this time, interested parties are invited to express their views and any concerns about the proposed change to the admission arrangements at Noadswood School. To this end, the Trustees propose to change the Planned Admission Number to 210 students from September 2026. No other changes to the Admissions Policy are proposed.
